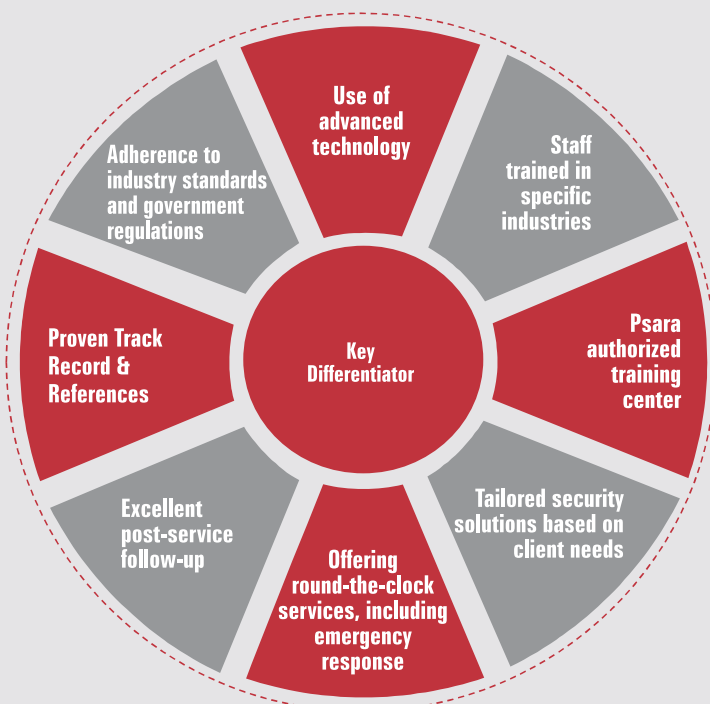

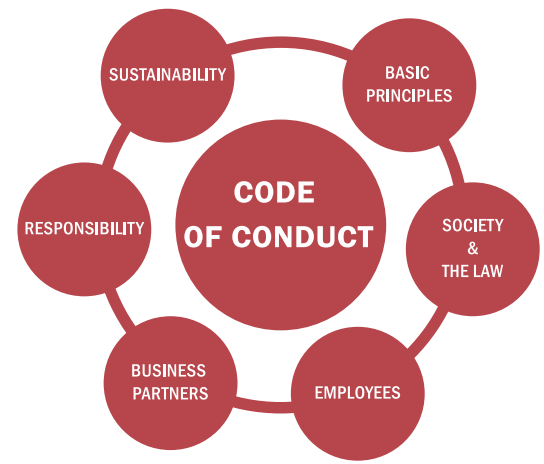

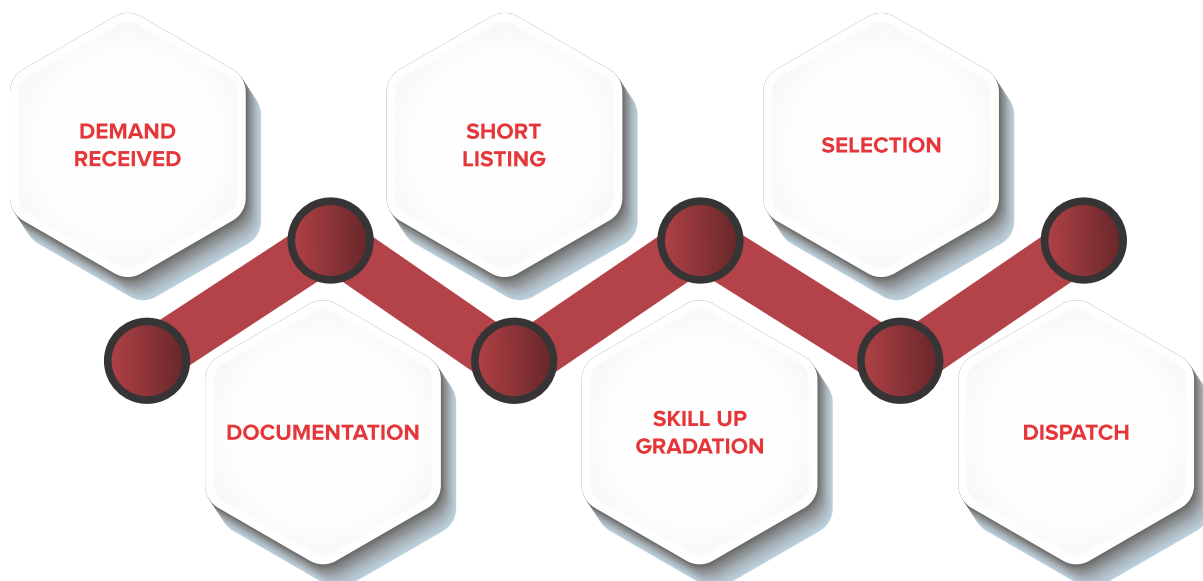


CODE OF ETHICS

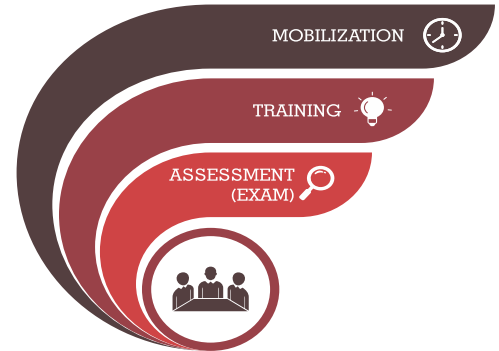

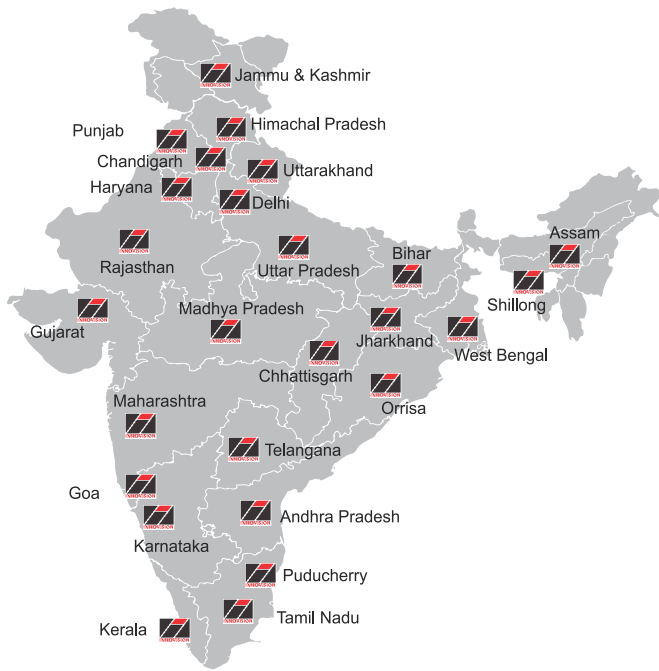

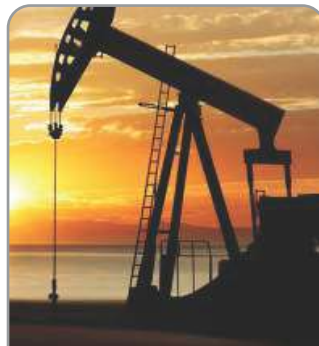
